Treasurer's Report September 30, 2016

At the end of September Regency's net operating cash was \$344,000. Our reserve assets totaled \$993,000.

At this time a surplus of approximately \$60,000 is anticipated at year-end and will be carried into 2017 to partially offset higher operating costs next year from the Country Club and Comcast.
